1. INTRODUCTION

The Tobacco Board, flagship under the ministry of commerce and industry has decided to implement a country-wide portal to ease and facilitate procedures for traders associated with the Board. The software application will act as an end-to-end system wherein traders can handle their all activities entirely on-line starting from Registration, Renewals, *Filling of Returns*, RCMC Certificate registration and GSP certificate. The end-to-end portal has the following key modules:

- Traders' Registration
- Traders' Returns
- RCMC Certificate
- GSP Certificate

TRADERS RETURN E-FILING MODULE – OVERVIEW

Before you begin:

In the software application, traders will be identified with a unique ID. The traders will be required to register in the trader registration module as a pre-requisite for participation in the online returns filing of the application.

Only the traders having active registration with the tobacco board can participate in online return filling and have authorized entry into the portal. Given the sensitivities, traders will be allowed to register in the portal only after their identity and the veracity of their claims have been verified.

Once registration is approved for the trader and the registration status is “Registered”, the trader can file online returns under that particular category. Trader has to ensure that his registration with Tobacco Board is approved before filling his online returns which otherwise can also be tracked by him through the application.

2. PRE-REQUISITES

The Trader must have the following:

- 2.1. A **broadband Internet connection**, it is suggested to have minimum 512kbps line. This is required for ensuring faster response while accessing information, processing and uploading of files. Some of the common broadband service (and other High-speed Internet service) providers are BSNL, Airtel, Sify, Reliance and Tata VSNL and more
- 2.2. You need to go to **PORTAL** using the URL <http://www.tobaccoboard.in> to enter the Information Page as indicated in the following screen shot.

- 2.3. In the software application, traders will be identified with a unique ID. The traders will be required to register in the trader registration module to obtain their unique Id, which is a pre-requisite for participation in the portal activities.
- 2.4. The portal is compatible with all browsers, however **Mozilla Firefox** is preferred.
- 2.5. A valid e-mail account with enough space to receive mails. If you are a regular trader to the Tobacco Board we recommend a dedicated email account and an alternate e-mail account in case the preferred e-mail service has some problem of receiving and sending

mails. There are many free mail services available on the internet today like Hotmail, gmail, Yahoo mail, Rediffmail, Sify mail etc. There are many paid services available if you prefer. Following are the links to some of these e-mail service providers.

3. PROCEDURE INTRODUCTION:

This section details what the documented procedure(s) is and business information about when it should be used. This section also provides information about why a procedure(s) is important and the context in which it should be utilized.

Trader returns module has been divided into 3 parts.

- Filling of all tobacco transaction made by the trader throughout the year.
- Submission of Return Form as per the category
- Payments of Late Return Fees (if any)

Note: Returns once submitted for a particular period by the trader cannot be changed later. Hence, traders shall ensure thorough confirmation before submitting his returns to the board.

Once trader submits the returns, it can be viewed and printed any number of time but cannot be edited or resend.

3.1. Filling of all tobacco transaction made by the trader throughout the year

Traders once registered with the board can make entries of all the tobacco transactions made by them during anytime of the year, without considering the month for filling the returns as the software application is designed to help trader in way to ease the return submission process by auto calculating the traders return as per tobacco board format.

The traders may use the software more as a daily use transaction account and keep making entries on a regular basis to the application as and when trader desire. In case of NO transaction also the software application will calculate the **NIL** return for the traders (This shall be explained in detail in following user guide).

Trader may use this software as tobacco passbook having account of all the tobacco transactions made by them throughout the year facilitating them to have a record and reports.

3.2. Submission of Online Return

For the ease of the traders, Online Return submission is been designed as simple as just click of a mouse button wherein software will auto calculate and generate the return as per the boards format, post to all entries made under transactions by the trader.

This will make it much simpler for the trader to submit his returns anytime as applicable for that period/month. The trader can make entries under transactions as and when desired and just click the submit button under the returns.

The traders can verify, edit and print his returns whenever they want before submission to the board. Once the return for a particular month is verified and submitted by the trader it **“CANNOT”** be edited/resend. However it can be viewed and printed.

(This shall be explained in detail in the following user guide)

3.3. Payments of Late Return Fees (if any)

Traders submitting their returns for a particular period/month after a permissive duration are liable for Late return fee. The software shall auto calculate and provide details of the Late return fees (if any) applicable to the trader depending on the date of submitting the returns.

Payments can be made in online and offline mode. Trader can choose either online payment or offline payment mode as per his convenience and make the payment.

Online Payment: Debit Card, Net Banking, Credit Cards

Offline Payment: Demand Draft

Note:


1. Payment made through offline mode, where trader needs to furnish the details of Demand Draft and upload a scan copy of the same and send the original to the Tobacco Board H.O, Guntur.
2. Offline payments approvals are subject to receipt & verification of details to the physical copy of DD sent by the trader.









4. ONLINE RETURNS SUBMISSION:


Manufacturer can submit online returns once its registration for the particular is approved by the board. The trader can Login to application by filling its login details. Once successfully logged in the trader shall be taken to the homepage

Once in homepage the trader can access to the category under which he is registered by clicking on it.

Below screenshots illustrates the various stage of the application by the trader and you may also notice multiple companies and multiple categories as show below

The various stages of Application processing are


- **Application Incomplete:** Trader has filled the application but has not submitted it to the Tobacco Board and trader cannot file any returns till he is approved as a registered trader by the Board.
- **Submitted:** Trader has submitted the application and is awaiting for Board's approval

- **Registered:** Traders post approval by the Board will be updated as Registered Trader


For ex. In screenshot above the ABC Company is granted approval under all the categories the status of the categories is **“Registered”**

Once traders status is updated as **“Registered”**, trader may click on it and navigate into the dashboard under the particular category and perform all the activities associated with the particular category (ex. Returns Filing, Applying for RCMC and GSP certificate (as applicable to the trader))


Once Manufacturer of Tobacco clicks on **“Registered”** under the particular category they can find dashboard associated to that category.

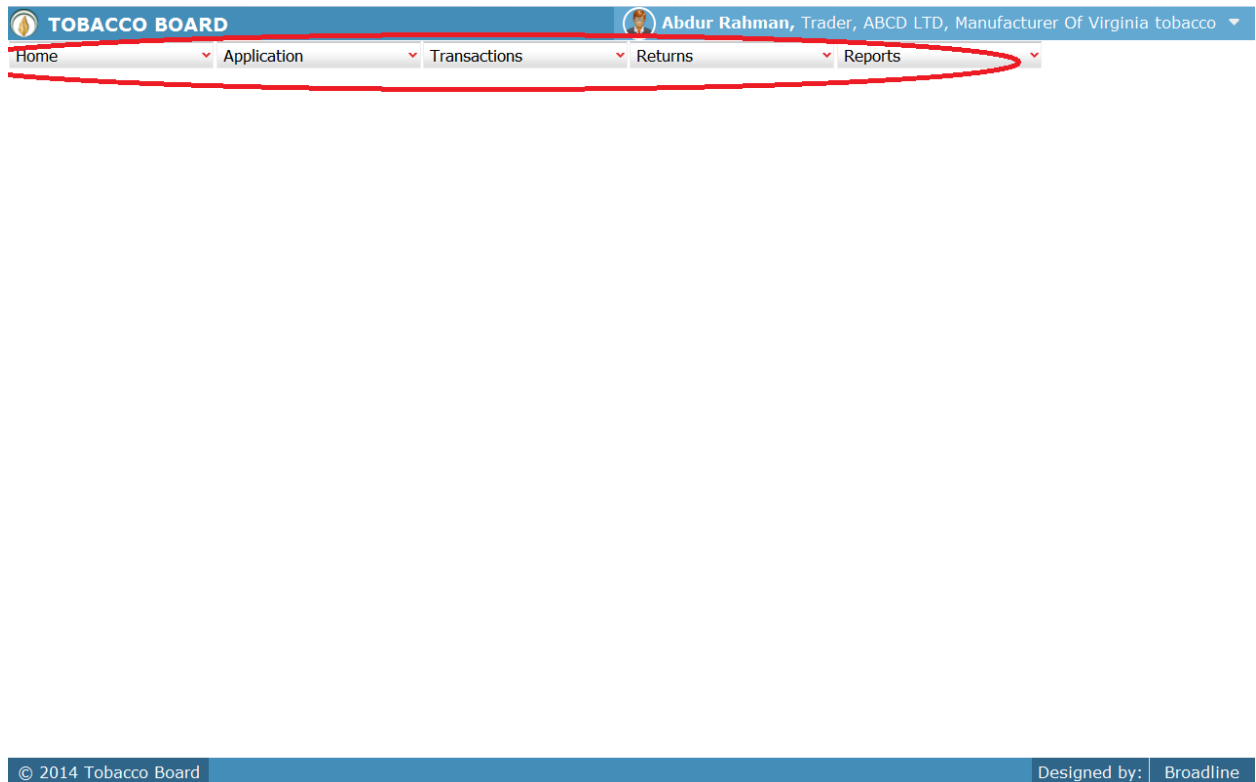

Above screenshot shows the screenshot for the dashboard of a trader under particular category with the following menus.

- **Home:** This menu can be used by the trader to navigate back to his home page
- **Application:** Under this menu trader can select option Application List and view all the applications they have submitted and all the information about it.
- **Transaction:** This menu is the main use for the registered trader as they can make entries of all the transactions of tobacco they do under that particular category
- **Returns:** This menu will associate with all the returns the trader will do under the category and also view all the returns submitted previously by the trader.
- **Reports:** This menu displays all the information related to the stocks particular trader are having available under the particular category.

4.1. Returns Submission Procedure:

The application has been designed by re-engineering the regular return submission process by the trader and has been made more of a trader friendly processes where the trader can log in and update his day to day transactions under the “**Transaction**” menu whenever he wants i.e. on a regular basis as per his daily transaction or on a single day giving all his monthly transactions at one go.

The process of returns is where the trader under the “**Return**” menu can just select the month. The system will automatically make all the calculations as per the information entered in the “**Transaction**” Menu and generate the Return Form of the particular category as per Board’s Format and trader can print ,verify and submit the return when the trader is confirmed that details of the return are correct.

Manufacturer of Tobacco can click on the “Transactions” menu to make entries of their tobacco transactions they have performed. (“Highlighted below in red circle”)

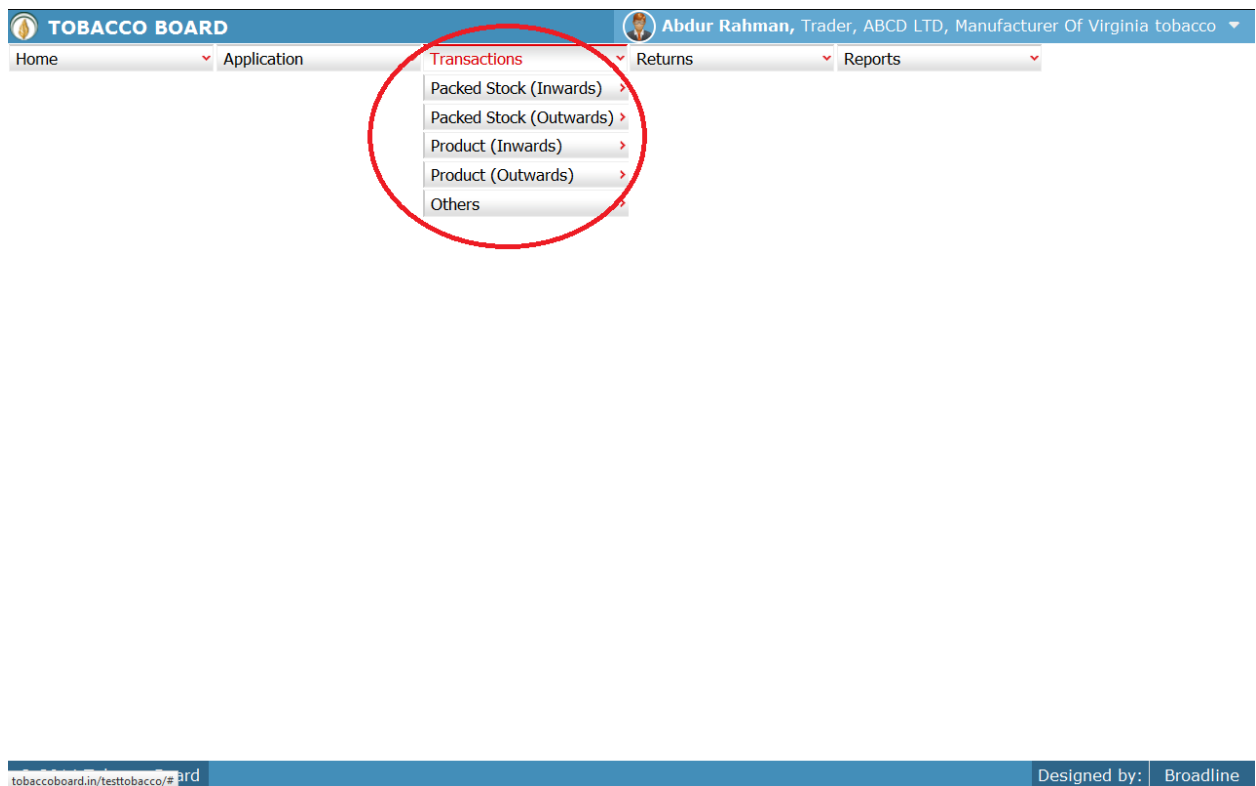

Trader can find under the “**Transaction**” menus which are

1. **Packed Stock (Inwards):** The term “Packed Stock Inwards” menu is to club all the transactions of packed tobacco that Manufacturer has made for various purposes like Transfers from own Dealers/Exporters of Tobacco, Imports etc.
2. **Packed Stock (Outwards):** The term “Packed Stock Outwards” menu is to club all the transactions of Packed tobacco that Manufacturer of Tobacco has made for purpose like Transfer for (Job Work) etc.
3. **Product (Inwards):** The term “Product Inwards” menu is to club all the transactions of tobacco products that the Manufacturer of Tobacco will be performing like Transfers from own processors, Transfer from others, Imports etc.
4. **Product (Outwards):** The term “Product Outwards” menu is to club all the transactions of green/raw tobacco that Manufacturer of Tobacco has made for various purposes like Sales to traders, Domestic sales, Issuance for Job work etc.
5. **Others:** This menu is provided to make entries of all the miscellaneous activities made by the Manufacturer of Tobacco in detail like inter-units transfers of tobacco, Details of Productions etc.

Each menu has been categorized clearly to ease the trader to make their entries efficiently under each sub menu for each transactions and the menus are inter linked to each other in a sync to help them manage all the tobacco details without doing much data entry.

For ex: Trader unless makes entries under Packed stock (Inwards) like purchase they cannot make entries under Product Stock(Outwards) like sales/Transfers as all the menu under the transactions are inter linked in a logical manner.

“Unless there is any stock Inwards there cannot be any stock (outwards)”

This simple logic is followed throughout the application everywhere.

4.2. Packed Stock (Inwards)

All the packed or prized tobacco transactions concerning to buying or procuring tobacco from various sources by the trader has been categorically classified under this menu

Below Screenshot shows the list of sub menus under Packed stock (Inwards) (“Highlighted below in red circle”)

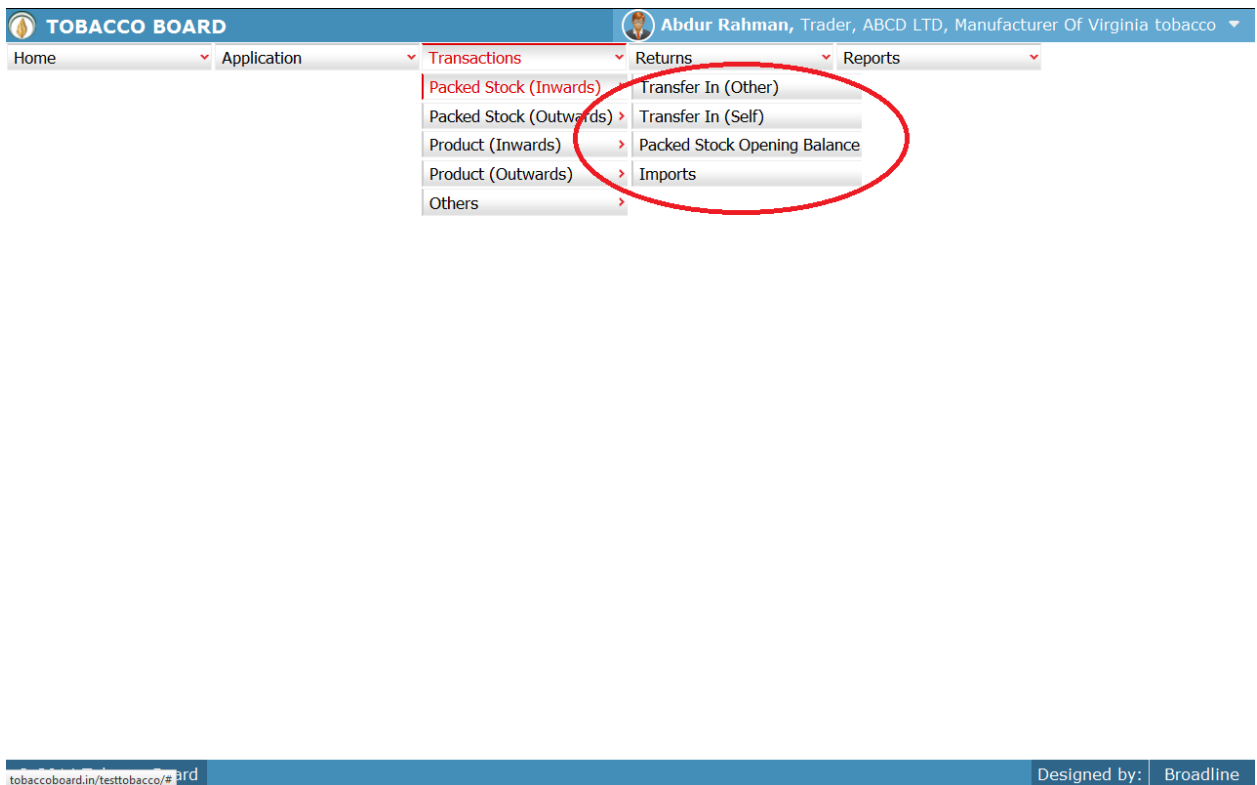

4.2.1. Packed Stock Opening Balance:

This is only a one time screen that the trader has to fill when he logs into the software application under this category for the first time.

The trader can click on this sub menu and will be viewing the below screenshot.

Trader can see in above screenshot the Packed Stock Opening Balance screen (“Highlighted in red Circle”). This is the main screen for the Packed Stocks opening balance details (We may call it summary sheet)

Once the trader navigates to this screen they can enter the details of all the packed Stocks available with the trader at that point of time from where they will start filing returns of any period.

For ex: If trader had submitted returns till month of July “Manually” and is filing “Online” returns from month of August, they have to fill the opening balance of packed stock for the month of August into the application initially for the first time while using this application.

Once a single online return is submitted this screen shall not be in the list under the Packed Stock (Inwards) menu and the opening balance for the subsequent month will be auto calculated by the application.

➤ **How to make entry into this screen?**

Manufacturer has to choose the transaction month and year as shown in Figure 7 above (“Highlighted in red color rectangle box”).

- i. **Transaction Month:** Trader needs to choose the month for which the he want to make entry of the tobacco transaction done.
- ii. **Year:** Trader needs to choose the year along with the transaction month for which the tobacco transaction entry is to be made.

Note: Application will always be showing current Transaction month and year as default value, but the trader can change this by choosing other period by clicking on the drop down menus.

Once the Transaction period is chosen the trader can go ahead and make entries of all the packed stocks available with the Manufacturer.

Entries can be made by clicking on the Add Button () on extreme right hand side of the table as shown in **Figure 7**

On clicking the add button the following screen is opened as shown in below screenshot.

Trader may observe that as per the selection of transaction year made in previous screen the Transaction period is shown here (“Highlighted in red Circle”).

Crop Information:

Trader needs to provide following details of the crop available as opening balance

a) Tobacco Details:

This selection has to be made in various screens by the trader as seen in above screenshot you may find button.



Select Tobacco Button: As this is a repetitive process trader should understand to use the button.

- I. Trader needs to click on the select tobacco button and the list for tobacco varieties will be shown to them as illustrated in below screenshot.

Following is the list of tobacco varieties that is opened when the “Select Packed Stock” button is clicked by the trader the trader may choose the tobacco variety which as per his choice by clicking on the variety.

Trader may see options as “Packed Stocks” (“Highlighted in red Circle”) in **Figure 9**. If the trader needs to make entry of any packed stock tobacco they may choose by going to the sublevel and Click on the “Select” button below

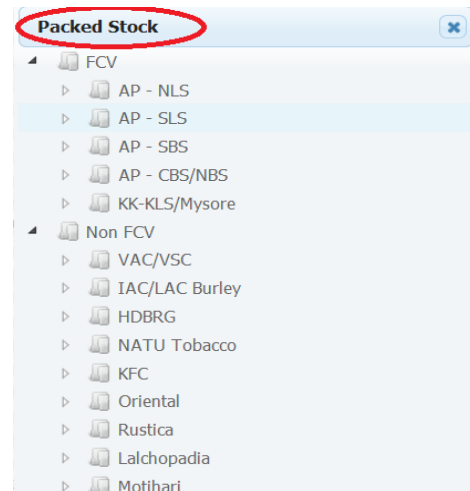

- II. Trader can choose any stock in the list by clicking on the node and choosing the packed stock at the last node only.

Trader Can click on each node to explore the below levels of the particular variety.

Note: Selection can be made only till the end level and a particular variety cannot be chosen if any underlying level is prevailing below that variety.

Therefore the trader needs to go to the end level and click on the variety to choose it.

For ex: A trader who wants to choose a packed stock RTL/MS that is FCV and from soil region AP – NLS as shown in Figure 10. He need to click on node points (“highlighted in Red Circles) and choose the end level and click the “Select” button below as shown or click on “Cancel” button to cancel the selection made.

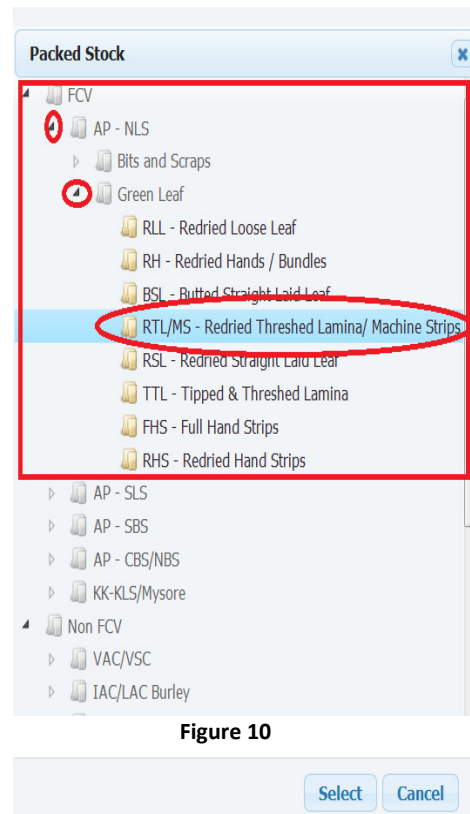

It can be observed that the Tobacco details are filled in (“Highlighted in red circle”). Trader can still change the Tobacco details by clicking on it and choosing other packed stock.

- b) **Year** : This is the crop year of the Tobacco chosen by the trader.
Trader can click on the drop down and select the crop year.
- c) **Grade** : Grade of the tobacco needs to be chosen from the drop down.
- d) **Type** : Trader needs to choose whether the entry of packed stock made is for “Self” if the packed stock is from own purchases/transfers and “Job-Work” if the packed stock was received from **other manufacturer** for any job work.
- e) **Unit** : Trader needs to mention which unit name at which the packed Stock is stored/handled.
- f) **Quantity** : Trader has to fill in the quantity of tobacco mentioned (in Kgs).

Once filling in the entire details trader may save the entry by clicking on “SAVE” button below  as shown in **figure 11**.

The Packed stock opening screen (we may call as summary sheet) will be as below screenshot once entry is made.

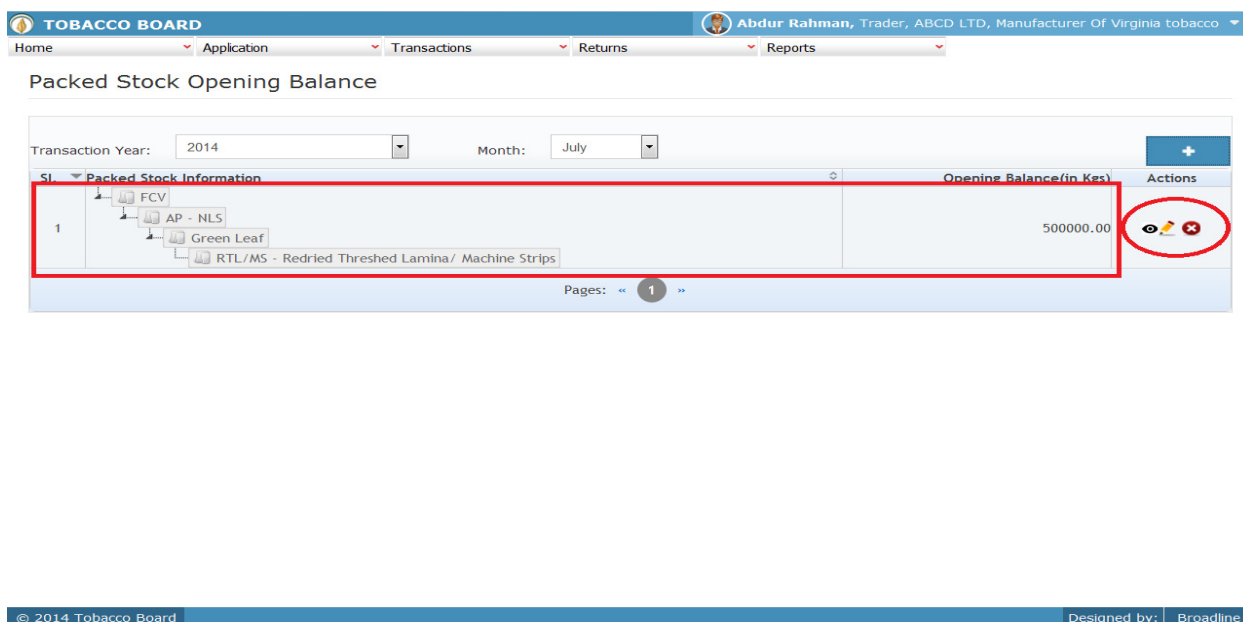

Trader may observe that record is successfully saved in the packed stock opening balance screen (“Highlighted in red color rectangle Box”). The trader can make multiple entries to this screen by again clicking on the add button at the right hand side of the table.

Note: After making an entry you can find an updated table as above screen shot. You may observe the extreme right hand column of the table with column name as “**Action**”. This column will be present throughout the portal at various stages.

You may observe from above screenshot 3 images under Action column. All of these 3 icons have different functions.

1.  This image can be clicked to view the complete details of the entry.
2.  This image can be clicked on to edit any information in the list
3.  This image can be used for deletion of a complete row entry in the list

4.2.2. Packed Stock Imports:

Traders can make entries of all the Packed Tobacco Purchase from Imports made during a particular transaction period. By choosing the Transaction year and Month for which the entry is made, as shown in below screenshot (“Highlighted in Red Circle”)

Trader can make entries for any Imports of Packed Tobacco made during the transaction period by clicking on the Add button () as shown in **Figure13**.

The Packed Tobacco Purchase from Imports screen (we may also call as summary screen) can be used by traders to view all the entries made earlier (if any) by choosing the transaction year and date.

Details of all the Import purchases made by the trader will be listed in this screen and the trader may view the list and make entries by choosing the transaction period.

Entries can be made by clicking on the Add Button () on extreme right hand side of the table as shown in **Figure 13**

Trader importing the packed tobacco should first enter the Importer name and country from whom tobacco is purchased as shown in **Figure 14** (“Highlighted in red color”) and save it. Trader additionally needs to mention at which unit the imported packed stock is kept.



Crop Information:

Trader needs to provide following details of the crop

a) Tobacco Details:

This selection has to be made in various screens by the trader as seen in above screenshot you may find  button

b) Year : This is the crop year of the Tobacco chosen by the trader. Trader can click on the drop down and select the crop year.

c) Grade : Grade of the tobacco needs to be chosen from the drop down.

d) Quantity : Trader has to fill in the quantity of tobacco mentioned (in Kgs)

e) Value : Trader needs to provide the value for which the tobacco is purchased through import (in Lakhs).

Once filling in the entire details trader may save the entry by clicking on “SAVE” button below as shown in **Figure 16**

The Packed Tobacco Purchase from Imports screen (we may call as summary sheet) will as below screenshot once entry is made.



Trader may observe that record is successfully saved in the Packed Stock Import screen (“Highlighted in red color rectangle Box”). The trader can make multiple entries to this screen by again clicking on the add button at the right hand side of the table.

Note: After making an entry you can find an updated table as above screenshot **Figure 64**. You may observe the extreme right hand column of the table with column name as “**Action**”. This column will be present throughout the portal at various stages.

You may observe from above screenshot 3 images under Action column. All of these 3 icons have different functions.

1.  This image can be clicked to view the complete details of the entry.
2.  This image can be clicked on to edit any information in the list
3.  This image can be used for deletion of a complete row entry in the list


Similarly a Trader can make number of entries of Imports from various Importers made during a particular transaction period.

4.2.3. Transfer-In (Others)

Traders can make entries of all the Packed Stock transferred/received from other traders (Only Manufacturer) on “**Job-Work**” basis made during a particular transaction period. By choosing the Transaction year and Month for which the entry is made, as shown in below screenshot (“Highlighted in Red Circle”)

Details of all the transfers from other Traders made by the trader will be listed in this screen and the trader may view the list and make entries by choosing the transaction period.

Entries can be made by clicking on the Add Button () on extreme right hand side of the table as shown in **Figure 18**

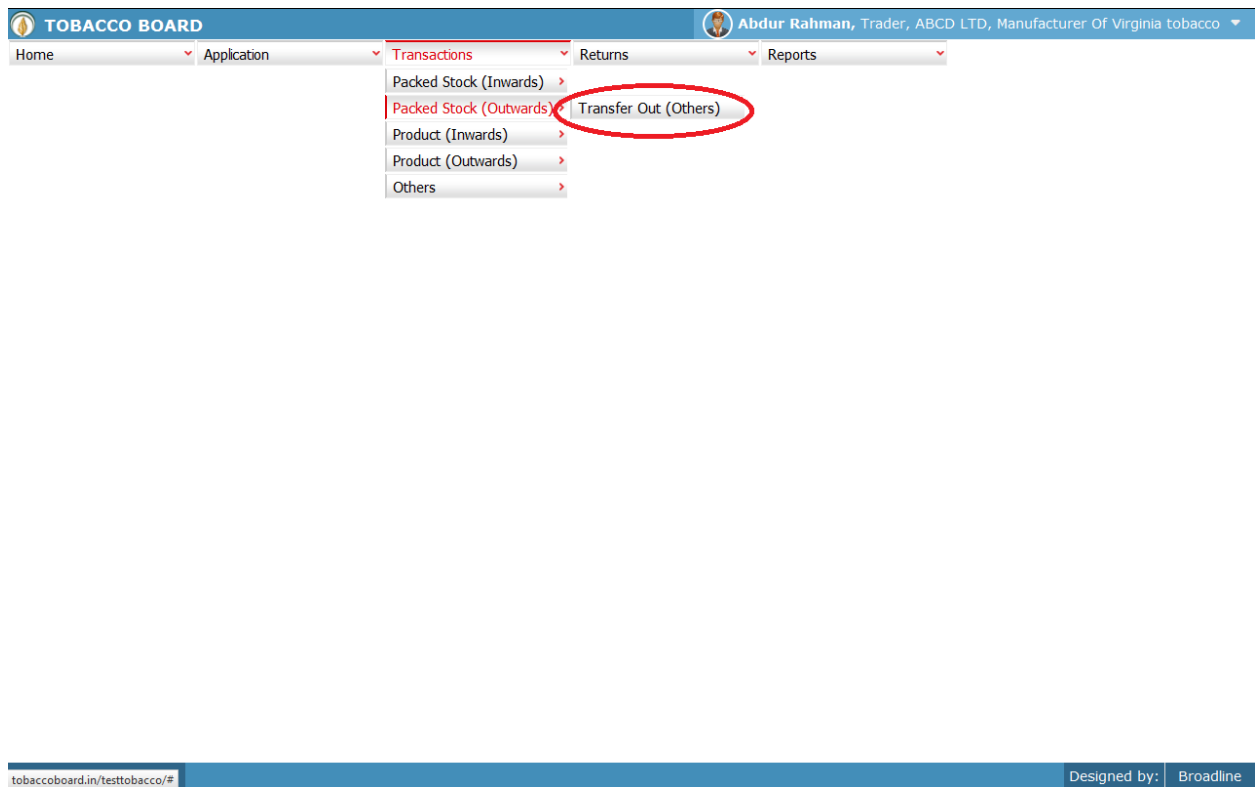



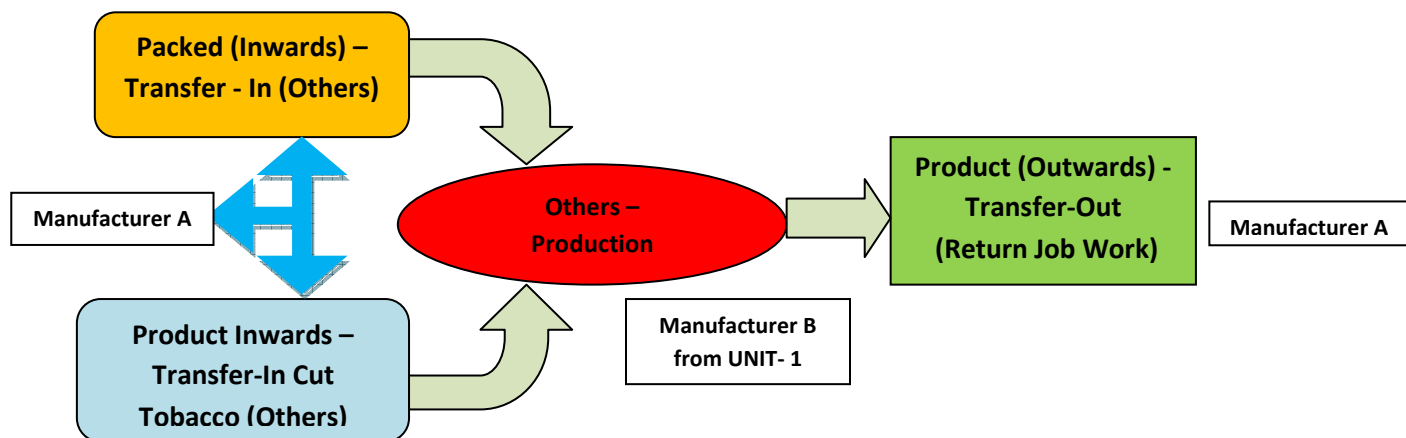

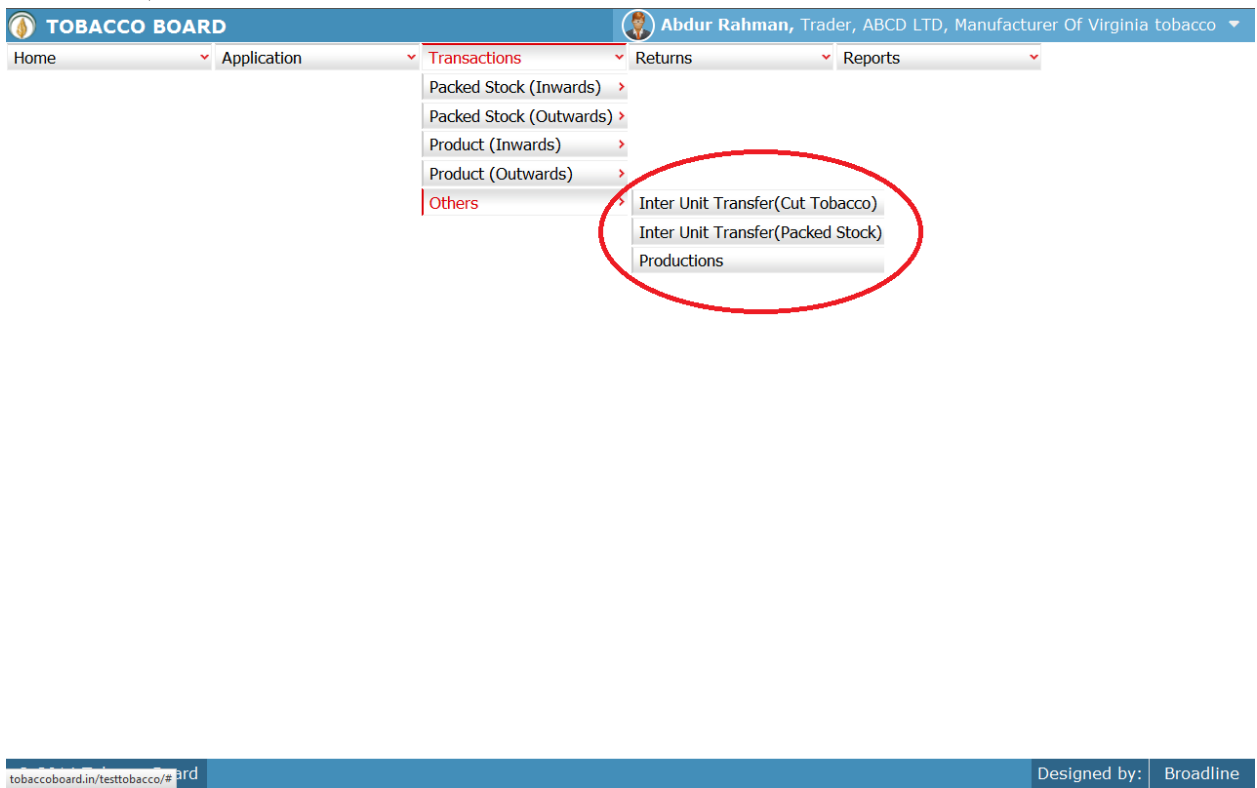

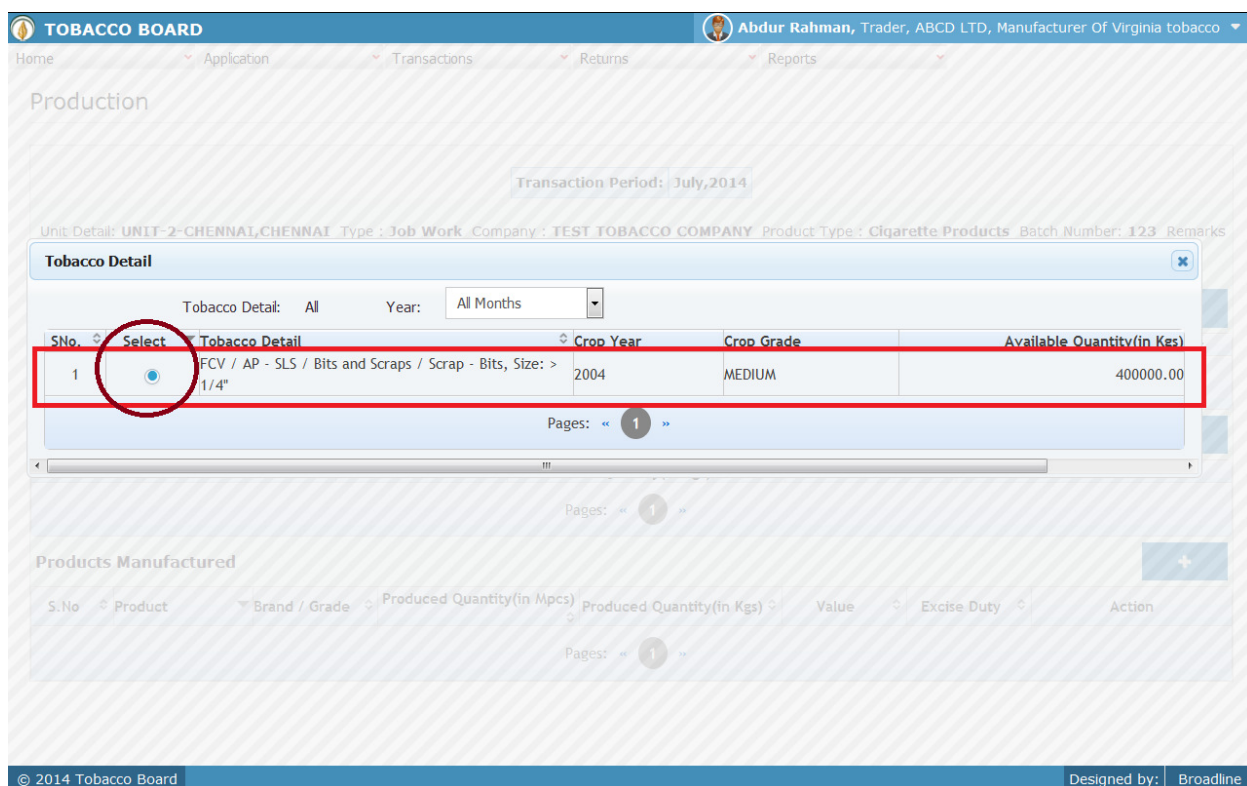

5. FILING OF RETURNS PROCEDURE:

Once trader has made relevant entries under the transaction menu as explained in detail in previous section they can move to submission of returns to the tobacco board. Trader must be clear that unless this stage all the entries made by them under transaction menu will only be available with them and tobacco board would not have any details of whatsoever entries made by the trader for a particular month unless trader has submitted the returns for that month.

Therefore, unless trader submits the returns (procedure explained below) it is considered that the return is not submitted by them even if the transactions are made.

However it is mandatory to make the entries under the transaction screens as software shall be auto calculating and generating the returns on behalf of the trader as per Tobacco Board's format based on the entries made by the trader under the transaction screen.

This feature is to reduce the ambiguity prevailing among trader community regarding the Board's format for returns and provide traders the ease by giving this software as daily/weekly/monthly tobacco transactions accounting for all the tobacco transactions made by the traders. With this trader has to only verify and click the "Submission" button and the software shall generate the returns as per the transaction entries made by them.

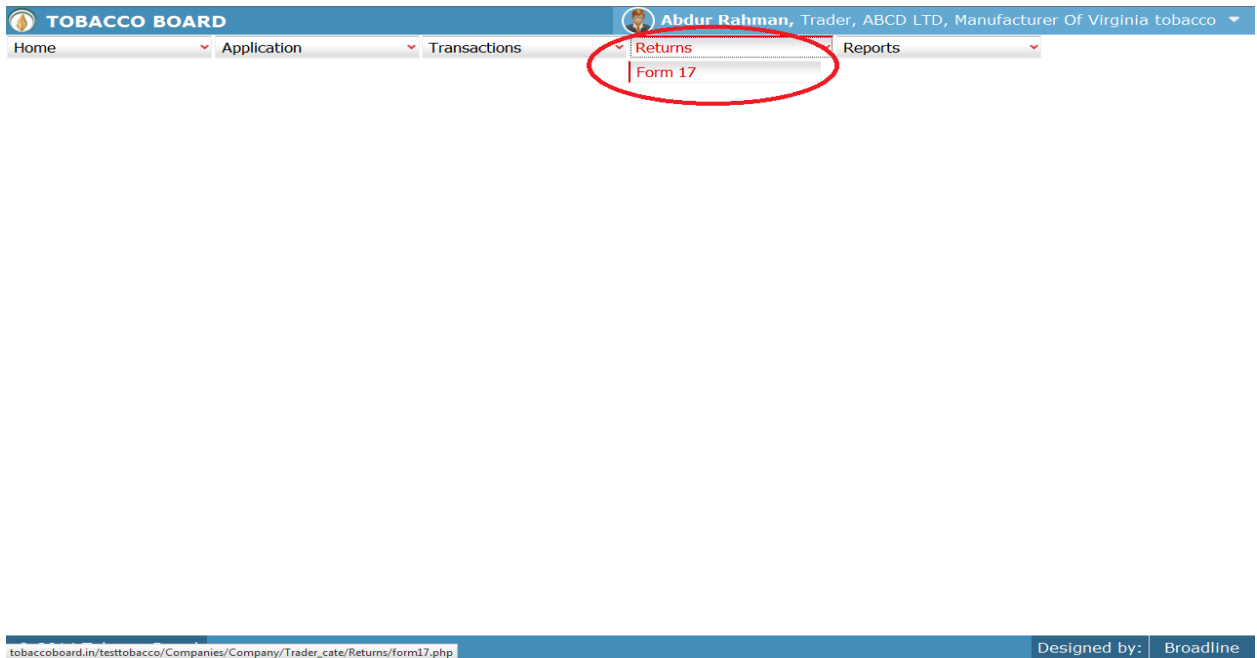

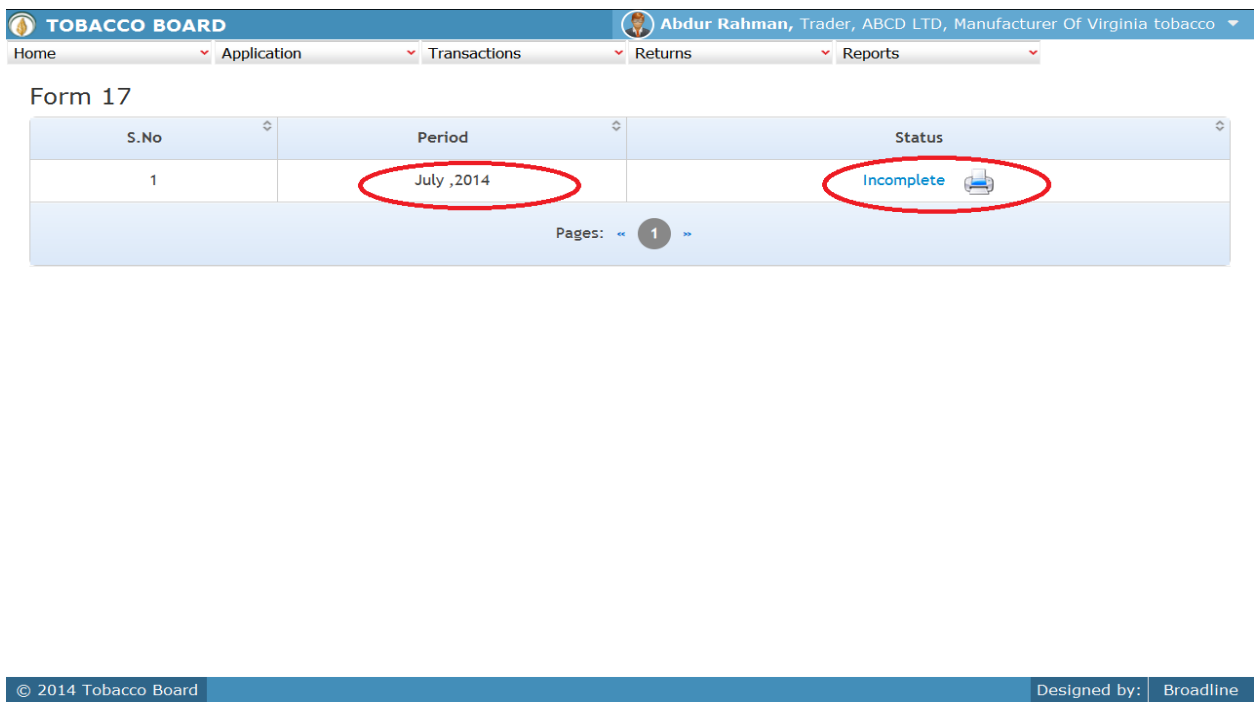



